- i) A Master's Degree with 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in a concerned/relevant/allied subject from an Indian University or an equivalent degree from /foreign University. However, for SC/ST/Non-Creamy layer SEBC/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims, muscular dystrophy; (d) Autism, Intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf blindness) for the purpose of eligibility and assessing good academic record for direct recruitment (ref. Sl. 3.4(1)0 of UGC Notification 18th July 2018) the requirement at master level is 50% Relaxation of 5% in marks is also applicable to Ph.D. degree holder who completed master degree prior to 19 September, 1991. (Clause 3.5)

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.



NOTE : NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.

SERVICE CONDITIONS

3. Minimum Qualifications and selections for direct recruitment as an Assistant Professor is as per UGC Regulations Notification No. F.1-2/2017(EC/PS), 18th July 2018 and as amended from time to time.
4. The retirement age and other conditions shall be as per Higher Education Department, Government of Odisha norms. Presently superannuation age is 60 years.
5. Reservation of posts will be according to Government of Odisha norms.
6. The selection committee shall be as per UGC notification 18th July, 2018, The Odisha Universities (Amendment) Act, 2024 and the pay structure shall be as approved by Government of Odisha.



1. The application received by due date will be screened / scrutinized.
2. The list of eligible and ineligible candidate(s) will be displayed on the website.
3. The shortlisted candidate will be called for the interview. A maximum of 10 candidates will be called for an interview for a single post, and for multiple posts, the number of candidates shall be called in the ratio of 1:10 as per the scores secured during scrutiny. 4. The Screening / Scrutiny and subsequent selection will be as per the UGC Notification 18th July 2018 and supported by the ACT and Statute of the University of Odisha.
